Any objection by the purchaser shall not give him the right to suspend or delay payment.

The materials must be used according to the rules of art.

Safety measures must be strictly followed on the site.

We may not be held liable for any use of our goods for a purpose different from its intended one.

Such disclaimer shall also include the third-party repair without our authorisation of a piece that may be identified as non-compliant by factory, default and the alteration of the finished product by the application of paint or another layer of coating, unusual wear, accidental deterioration, etc.

In case of any defect whatsoever, the client shall take all protective measures for the common interest of the parties.

The guarantee of our goods is provided for hidden defects that the sold products may have when used and that should normally have been revealed by our controls.

Eventual defects must be jointly confirmed by our representatives and acknowledged by us in case they are effectively attributable to the manufacturer, after contradictory examination.

In case of a fault detected and acknowledged by the Edilfibro After-Sales Service, the manufacturer shall be responsible for taking the appropriate measures to bring the delivered goods into conformity.

The repair carried out under this guarantee shall not lead to an extension of the original period of guarantee.

This guarantee does not cover wear and tear caused by extraordinary circumstances, such as hail, storms, flooding, mechanical damage of surfaces, reckless movement on the roofing, exposure to chemical or biological agents, maintenance work, faults and any other act of God.

## **COLORPLUS CORRUGATED SHEET GUARANTEE**

EDILFIBRO hereby guarantees for a period of ten years following its delivery a globally homogeneous evolution of the appearance of the upper side of the Colorplus corrugated sheets (Black, Green, Red, Brick, Brown and Ochre) with the preservation of its base hue, considering the patina over time that is usual for outdoor-exposed materials.

Since weather factors may vary depending on the site, location, roof slope and length of exposition, each roof or every pitch of the roof may change accordingly.

Slight shades of hue are inevitable.

Considering the aforesaid aspects, our guarantee is provided in cases where the colouring of the sheets no longer look reasonably in harmony with the whole of the roof, in which case EDILFIBRO commits to remedy it using any efforts that it may deem appropriate.
